1.1 INTRODUCTION

Introduction:

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Curricular Aspect:

The college is affiliated to Sant Gadge Baba Amravati, University Amravati. The college follows the curriculum designed by university. Our institution offers two programmes i.e. B.A and B. Com. Along with these two programmes two certificate courses are run at college level for supplementing the subject knowledge.

The institution ensures effective curriculum delivery. Academic Calendar is prepared at the outset of every session. The academic calendar is uploaded on institutional website. Our teachers prepare Annual Teaching Plan. The syllabus is executed systematically through proper time table.

The teachers contribute in university examination by doing paper setting and evaluation. Teachers aim to address cross-cutting issues like gender, environment, human values and professional ethics through respective courses. Apart from it various co-curricular and extra- curricular activities are organised to sensitize the students. The Environment Science is a compulsory subject for second year. The curriculum is enriched by organising guest lectures, study tours, poster competitions, and quiz competitions and so on. A review of syllabus completion is taken by Principal.

Feedback on curriculum is taken from different stakeholders.

Teaching-learning and Evaluation

Teaching Learning and Evaluation:

The college admits students on the basis of first come first serve basis. Diagnostic test is conducted to indentify slow learners and advanced learners. After the test outcome the college takes special initiatives like guest lectures, certificate course, group discussion, remedial classes etc. Student centric teaching methods are in practice. Our teachers organise special programmes and activities such as study tour and industrial visits, study forums, poster exhibition, seminar and presentation for enhancing learning experiences of the students.

Our teachers use ICT enabled tools for exp. Google classroom, Google form, LCD Projector; zoom app. Teachers provides notes and other study material on whats app groups in pdf format. These ICT tools enhance the teaching- learning process. In Covid pandemic our teachers conduct online lectures on zoom app. Mentor –Mentee scheme is run effectively in the college. Through this scheme academic and personal counselling is done. Our three teachers have been awarded Ph.D.

The college follows the mechanism in case of Internal Assessment laid by university. Examination Committee is formed to make Internal Assessment process transparent and robust.

The Programme Outcomes and Course Outcomes are displayed on website and communicated with the stakeholders.

Research, Innovations and Extension

Research, Innovations and Extension:

The college tries its best to nurture research culture and teachers are encouraged to participate in workshops and conferences by providing them financial support. Our three teachers are PhD holders and four teachers are pursuing PhD. All the teachers published their research papers in reputed journals and National and International conference proceedings. Even some students also published their research papers. Our two teachers have published their books also. The college has organized state level workshop on "NAAC Revised Accreditation Framework" and National Level online conference on "Use of ICT in Teaching-Learning: Opportunities and Challenges." under UGC Paramarsh Scheme. As far as extension activities are concerned our NSS unit along with all the departments play crucial role in conducting various activities in nearby society. Various extension activities are organised such as Voter Awareness Rally, Tree Plantation, Beti Bachav Beti Padhav, Plastic Awareness etc. The college has signed some MoUs with other educational institutions and industry also.

Infrastructure and Learning Resources

The college has adequate teaching-learning facilities. There are 6 well equipped classrooms are available in college. The college has a good library with enough books, journals and newspapers. Computer Lab is also available for students. There are two LCD projector are made available for the purpose of teaching-learning. Internet facility is provided by the college. Besides it 2 printers and computers are available for administrative purpose. CCTV cameras are installed in the college premises. All the necessary equipment for sports is provided to the students for participation in various tournaments. The college provides its playground for outdoor games. Our Physical Director conducts yoga sessions for students in college auditorium. Annual gathering and other cultural activities are organized in college auditorium. To maintain and utilize physical and academic facilities the college has established system. We have formed some committees to take care of maintaining and utilizing available facilities in the college. Apart from the committees, the responsibilities are given to teachers and non-teaching staff members.

1. Multidisciplinary/interdisciplinary:

The college is affiliated with Sant Gadge Baba Amravati University and Choice Based Credit System will be implemented by the university from the session 2022-2023. The college provides two

	programs in Arts and Commerce faculty presently. The IQAC is going to plan to organize a workshop on NEP. Since the college is affiliated to SGBAU, we follow all the rules and regulations of concern university and Gov. of Maharashtra. As per the information provided by the university, we will introduce the Multidisciplinary and Interdisciplinary approach as we have two faculties (Arts and Commerce) so students can choose any subject from both the faculties. We also try to introduce new courses.
2. Academic bank of credits (ABC):	2. One of the provisions of the National Education Policy 2020 (NEP 2020) is the introduction of the Academic Bank of Credit (ABC). ABC will allow students of undergraduate and postgraduate degree courses to exit the course and enter. The college is affiliated to Sant Gadge Baba Amravati University. Our college is down to follow the courses and rules and regulations of affiliating university. The university has taken an initiative to introduce CBCS. The initiative taken by the university is at preparatory phase. The institution will register for ABC in near future.
3. Skill development:	The two certificate courses are provided to the students. The department of English runs the Certificate Course "Business Writing" and the department of Political Science runs "Leadership Development in Politics". The institution has signed some MoUs with local industry to provide training of poultry farming and making leather bags. The institution plans to introduce some vocational courses also.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	4. In order to promote and integrate Indian culture, art, and languages, the college has already organized such type of activities. The department of Marathi organizes programs like "Marathi Bhasha Pandharwada" and "Marathi Bhasha Savardhan". The department of History arranges historical trips for students in order to inculcate Indian values and create awareness about our rich culture and heritage. In annual gathering many programs are organized to promote Indian culture and values. The subject Marathi is a compulsory subject for all the programs. The college offers Marathi Literature as an optional subject.

5. Focus on Outcome based education (OBE):	The programme outcomes and course outcomes are available on institutional website. The institution is trying to introduce some skill based courses in order to get employment to the students. The students will be given internship opportunities in local industry. The institution will sign some MoUs to reputed institution to provide research guidance.

When the teaching-learning process was affected due to covid-19 pandemic we conducted online lectures. Our teachers provided study material trough whats app groups. Recently some teachers posted their lectures on you tube also. This is our preparedness regarding the development of e-content. 1.1 Curricular Planning and Implementation

1.1.1 The Institution ensures effective curriculum delivery through a well planned and documented process

Response:

Our college is affiliated to Sant Gadage Baba Amravati University, Amravati. Thus we follow the curriculum designed by our parental university. Curriculum and its proper implementation is very integral part of teaching-learning process. It needs a systematic mechanism. Our institution follows further mechanism for effective curriculum delivery.

- 1. Every year at the outset of academic year, the time- table committee prepares the time-table for the entire session.
- 2. Academic Calendar is prepared at the beginning of the session.
- 3. Apart from institutional Academic Calendar, every department prepares its own Academic Calendar.
- 4. Teachers maintain Academic Diary and same is audited by the Principal.
- 5. Daily study material and lesson notes are prepared by the teachers.
- 6. The teachers spend few lectures for the introduction of the syllabus and clear the university examination pattern to the students.
- 7. To evaluate the progress, unit tests are conducted by every subject teachers.
- 8. For Internal Assessment, assignments are allotted to the students and viva-voce is also conducted by respective subject teachers. In case of Internal Assessment pattern laid down by parental university students are made realize about the importance of Internal Assessment and its pattern.
- 9. For effective curriculum delivery every teacher plans comprehensive teaching plan.
- 10. To give the practical exposure of the syllabus, study tours are organized by some department.
- 11.It is very necessary to review the curriculum delivery and to know the progress of teachers and students in case of curriculum. For this purpose we form Staff Council. In the meetings of Staff Council the head of institution i.e. Principal takes review of curriculum delivery.
- 12. We try our best to students can create their interest and get more knowledge about the subject. Hence guest lectures are organized by every department.
- 13.In the context of Indian Education system, students are from different background, some are advanced and some are slow learners. To indentify we conduct 'Diagnostic Test'. After identification of advanced and slow learners we give them proper treatment.
- 14. The institution takes care of slow learners and Remedial Classes are conducted for them. Personal guidance and counseling are helpful to them.
- 15. Some certificate courses are introduced for advanced learners. Additional facilities such as extra books, personal counseling internet facilities are provided to them.

16. Mentor-Mentees scheme is run by the college. It is very helpful to know the students thoroughly.

17. ICT based teaching is an effective medium for successful curriculum delivery.

Versatile Development of Rural Girls Student

2) Objectives of the Practice :

Taking into consideration the issues and problems of girl students we set following objectives for this activity

- 1. To develop leadership quality among girl students of the college
- 2. To enable them to start small case business

- 3. To sensitize students in case of gender equality, laws about safety and security
- 4. To aware them about their health and empowerment
- 5. To promote rural girls to pursue for higher education

3) Context:

The above-mentioned objectives were set from the observation and analysis of the girl students. In our institution the maximum number of students are from rural and backward class of the society. We have found that the girl students were lack of self-confidence, we came to know the need of making them aware about their situation and about their future also. We had tried our best to convince the girls and we got success to some extent. Basically, the girl students of our institution are from rural area, the girls belong to backward class where the first generation is pursuing their higher education besides it their financial and social background affect their personality. So, the institution tried its best to change and develop the personality of girls. The institute organized various activities and programmes in order to make the girls self- confident and self-independent. While conducting the programmes and activities their overall development was taken into consideration.

4) The Practice:

Following initiatives were taken to achieve the goals of the practice

In rural area the parents are orthodox and not willing to admit their girls for higher education, sometimes some girls get married in between their degree education and have to leave their education. In these cases, we tried our best to convince the girls and their parents to pursue their education even after their marriage.

We encouraged the girls to participate in cultural and other activities in the campus and outside the campus. Before the motivation and encouragement the girls were not willing to participant but after some guest lectures of eminent women speaker and the motivation and encouragement of the staff, the girl students gradually participated in various programmes.

To make the girls self-dependent and self-confident the college arranged various programmess, guest lectures, visit to self-help group and small case industry. Some training programmes were organized by the college.

Our Women Empowerment Cell organized activities in order to aware the girls about their health and laws about safety and security
